## President's Report

Respected Members of the UVCE Graduates Association,

It gives me great pride and a deep sense of gratitude to present this year's President's Report as we gather for the 5th Annual General Meeting of the UVCE Graduates Association.

The past year has been one of both consolidation and aspiration. Together, we have built on the foundation of credibility and trust established over the last several years. We are also taking bold strides towards strengthening our alumni ecosystem and deepening our commitment to the institution we hold dear — University Visvesvaraya College of Engineering.

One of the most notable milestones this year has been crossing the 2,000-member mark. This has not just been a numerical achievement, but a testament to the growing resonance of our mission among UVCEians across generations. Campaigns like the *ProudUVCEian 5K Run*, targeted outreach during reunions, and direct engagement with recent graduates have all contributed to this momentum.

On the initiatives front, the UVCEGA Scholarships Program continues to make a tangible difference — with over ₹15 lakhs in support disbursed this year, empowering nearly 86 deserving students. Our Mentorship program has evolved steadily, providing much-needed guidance and inspiration for students navigating academic and career choices. I take this opportunity to thank every alumnus who contributed — financially, intellectually, or through their time.

Perhaps one of the most visionary strides we have taken is through MARVEL — the student innovation lab we established. Over the past year, MARVEL has not only enabled over 100 students to complete Level-1 certifications but also sparked curiosity and confidence in areas like IoT, AI, and real-world problem-solving. With *MARVEL 2.0* on the horizon, we aim to scale both the breadth and depth of this platform — unlocking even more value for our students and the institution.

Our events and engagement efforts — from *Engineers Day (UVCE Sammilana)* to Silver, Golden, and Decade Reunions, to proud UVCEian 5k run/walk — have continued to strengthen the alumni bond and create new platforms for collaboration. The active participation of faculty and even the Director of UVCE at some of these events is a welcome sign of the growing partnership between the alumni body and the institution.

Equally important have been our *governance initiatives* to ensure UVCEGA operates with integrity, transparency, and long-term sustainability. This year, we crossed the ₹1 crore fundraising milestone, prompting us to strengthen our financial management systems. We have implemented a structured accounting framework, approved the acquisition of a Tally license, and appointed a part-time accountant to streamline processes and enhance financial oversight. A detailed authorization protocol is now in place to bring discipline and clarity to fund utilization.

Additionally, we have formalized communication protocols across digital and physical platforms, standardized the publishing of meeting minutes, and improved our internal documentation and handover processes. These reforms reflect our commitment to process-oriented governance and continuity, ensuring that UVCEGA continues to function as a high-impact, professionally run association.

As we look to the year ahead, we recognize that our work is far from over. We must:

- Continue to expand our membership and build a robust global alumni network.
- Strengthen student-alumni bridges through internships, mentorship, and entrepreneurship initiatives.
- Bolster fundraising and endowment efforts for long-term institutional support.
- And most importantly, champion the spirit of UVCE — one rooted in excellence, integrity, and collective pride.

I am thankful to every member of the UVCEGA Executive Committee, to our batch coordinators, volunteers, student coordinators, and every alumnus who has believed in this movement. A special word of appreciation to the college faculty and leadership for their openness to collaborate.

## Proceedings of the 4th Annual General Body Meeting of UVCE Graduates Association (2024)

We are pleased to report the successful conduct of the **4th Annual General Body Meeting (AGM)** of the **UVCE Graduates Association (UVCEGA)**, held on **July 21st, 2024**, at the KEB Engineers Association Hall, Bengaluru.

### Communication and Attendance

The meeting notice was widely disseminated through email, WhatsApp, and in compliance with the Association's bylaw, published in *Deccan Herald* and *Prajavani* on **June 25th, 2024**. Approximately **80 alumni members**, representing various graduating batches, attended the event.

### Opening Session

- The meeting commenced with an informal networking session over coffee and tea.
- At **11:00 AM**, due to quorum not being initially met, the meeting was adjourned for 15 minutes.
- At **11:15 AM**, the office bearers took the dais. The Secretary welcomed the gathering, confirmed quorum (post-adjournment requirement: 25 members), and formally opened the AGM with the President's announcement and the singing of the National Anthem.
- A moment of silence was observed in memory of alumni who had passed away in the preceding year.

### Highlights of the AGM

- The Secretary presented a brief overview of the previous AGM (held on **June 18th, 2023**) and referenced the availability of the detailed **Annual Report** via soft copies and QR codes.
- The previous minutes were proposed for approval by **N. Prabhu Prasad (1973)** and seconded by **Narayana Swamy (1969)**.

A special moment was observed as **Raghavendra Rao (1972)** requested a tribute to teachers on the occasion of **Guru Purnima**. With the President's approval, the gathering chanted "Guru Brahma, Guru Vishnu" to honour all educators.

The Secretary highlighted key achievements from the year:

- **Execution of 2023–24 Plans** as proposed in the previous AGM.
- **Membership Drive** surpassing 1600 members.
- Establishment and growth of **MARVEL Lab**, with over 100 students completing Level-1 courses.
- Flagship events such as **UVCE Sammilana** (Sept 2023) and **Alumni Soiree** (Feb 2024).
- Continued efforts like **UVCE Meet & Greet**, **Alumni Confluence**, and faculty meetings.
- Productive engagement with the **Higher Education Minister** (Nov 2023).
- **Scholarship disbursal of ₹12 lakhs** to 80 deserving students on **March 29, 2023**, supported by generous alumni contributions and **8 endowment funds**.
- Support for batch reunions including **1973 Golden Jubilee** and **1998 Silver Jubilee** celebrations.

- Updates on initiatives from **VisionUVCE**, the communications wing of UVCEGA, such as *Sampada*, *UVCE Chronicles*, *Unnathi*, *Best Class Competition*, and others.
- Infrastructure support projects including the library, official website, and digital platforms.

## Financial Report and Approvals

- The Treasurer, **Lomesh K G**, presented the financials: Income & Expenditure, Receipts & Payments, Balance Sheet, and Auditor's Report.
- Queries regarding **80G and 10BE certificates** were addressed.
- Approval for the financial statements was proposed by **H. N. Parthasarathy (1971)** and seconded by **Nanjunde Gowda (1981)** and **Suryanarayana Rao (1972)**.
- The General Body unanimously approved the continuation of **Prasanna Adiga** as Auditor for FY 2024–25.
- The **Budget for FY 2024–25** was presented and approved after clarifications on specific items such as event expenses and endowment fund management.

## Member Feedback and Discussions

- Concerns and suggestions were raised regarding **provisional membership conversion, uniformity in membership fees**, and the need for **dedicated resource management** for endowment returns.
- Volunteers came forward for mentorship, innovation labs, and academic engagements:
  - **Venkechar (1984)** expressed interest in setting up a new innovation lab.
  - **Srinivasan (1983)** offered to support a **technical lecture series**.
  - **Ramesh Babu (1971)** endorsed the value of one-on-one mentorship programs.
  - **Lt. Gen. Dr. V J Sundaram. PVSM (1957)**, at age 90, highlighted the need for stronger college-alumni collaboration.
  - Other alumni discussed potential improvements in operational coordination and community participation.

## Elections and New Committee

With the term of the current Executive Committee ending, elections were conducted. In the absence of Returning Officer **Dr. Anandaram KS (1964)**, **Maj. Gen. Neelakantappa** announced the unanimously elected new Executive Committee:

## Report for the year

### Membership

We are proud to share that the UVCE Graduates Association has crossed the significant milestone of **2,000 life members**, marking a strong and growing alumni community. This achievement reflects the collective effort and commitment of our team to deepen engagement across generations of UVCE graduates. Several targeted initiatives have contributed to this growth — from **on-campus outreach drives for graduating batches**, to **focused campaigns during reunion events** such as the 1974 Golden Jubilee and 2014 Decade Reunion. We also leveraged **digital outreach tools**, including personalized emailers, WhatsApp broadcasts, and QR-code-based registration links shared during events like **UVCE Sammilana** and the **ProudUVCEian 5K Run**. Additionally, alumni-led peer referrals and our consistent communication through *Sampada*, *UVCE Chronicles*, and social media helped build trust and visibility. As we move forward, this 2000+ strong member base not only strengthens our collective voice but also lays the foundation for greater alumni-led impact across UVCE's academic, innovation, and student support initiatives..

### Governance and Institutional Strengthening

Over the past year, UVCEGA has made concerted efforts to enhance its governance framework, focusing on professionalism, transparency, and continuity. A key milestone was crossing ₹1 crore in funds raised—prompting a renewed emphasis on financial discipline and structured operations. Significant steps have been taken to implement system-driven accounting practices, including the approval of a Tally license and appointment of a part-time accountant. Clear authorization protocols for payments and regular budget tracking are being institutionalized to ensure accountability.

On the communication front, structured protocols have been adopted across formal channels, including email, website, and social media, along with internal coordination tools. Efforts have been made to document proceedings, publish meeting minutes, and ensure informed participation of all EC members. Best practices such as agenda-driven meetings, respectful dialogue, and conflict resolution guidelines have been embedded into the functioning of the Executive Committee. These initiatives reflect UVCEGA's commitment to building a robust, process-oriented foundation for long-term sustainability and member trust.

### MARVEL – Lab

In the past year, the MARVEL (Multi-disciplinary Applied Research, Validation, and Engineering Lab) has continued to evolve as a cornerstone initiative of UVCEGA, aimed at fostering innovation, real-world problem solving, and industry-relevant skills among UVCE students. With an investment of over ₹15.5 lakhs to date, the lab has provided infrastructure, mentorship, and a structured learning path through tiered levels of engagement. In the last cycle, over 180 students completed Level-1 certification, gaining exposure to emerging domains like embedded systems, AI/ML, robotics, and sustainable technologies. The lab has also hosted multiple workshops, guest lectures, and project reviews led by experienced alumni

mentors, creating a collaborative, cross-disciplinary learning environment. “Aviation” domain was introduced in the current year.

As we look ahead, MARVEL 2.0 is being envisioned not just as a continuation, but a significant leap forward. The focus will shift toward deeper research enablement, more advanced project tracks, and expanding industry-alumni partnerships. Plans include introducing Capstone innovation sprints, forging startup linkages, and embedding product-thinking frameworks to take student ideas closer to real-world deployment. We are also exploring collaboration with other engineering institutions, innovation hubs, and potential CSR-backed sponsorships to scale the lab’s impact. MARVEL 2.0 will aim to position UVCE not just as an academic institution, but as a nurturing ground for future-ready engineers, technologists, and entrepreneurs.

## UVCEGA 5K Run/Walk – Rekindling a Celebrated Tradition

In 2025, UVCE Graduates Association was proud to revive the tradition of the UVCE 5K Run/Walk, a celebration of fitness, unity, and the enduring spirit of the UVCE community. Planning for the event began in December 2024, and despite a tight schedule, the organizing team swiftly launched preparations and opened registrations by the new year.

Initial sign-ups were modest, but thanks to targeted outreach among students and alumni, registration numbers surged by late January. The picturesque Cubbon Park was finalized as the venue, and meticulous efforts went into securing permissions, designing event T-shirts and medals, and ramping up promotional activities.

Generous support from alumni sponsors underscored the strong sense of camaraderie and commitment that defines the UVCE network. On the morning of March 16, 2025, over 750 enthusiastic participants gathered at UVCE by 6:00 a.m., organized decade-wise to collect their kits. Participants ran or walked through Cubbon Park's scenic trails, while dedicated volunteers ensured smooth coordination across logistics and safety. Upon completing the 5K, attendees regrouped at campus for refreshments, group photographs, and a celebratory breakfast.

## UVCEGA Scholarships 2024-25 : Fostering Student Potential through Alumni Support

As part of our continued commitment to student welfare and academic empowerment, the UVCE Graduates Association successfully executed the 2024–25 UVCEGA Scholarships Program, marking yet another year of meaningful impact.

This year, we received nearly 500 applications, out of which 150 students were shortlisted for interviews. A panel of 30 alumni volunteers conducted the interview process, ultimately selecting 86 deserving students for scholarship awards. The selection process upheld transparency, meritocracy, and a strong commitment to inclusivity across all departments.

- UVCE Boys' Hostel Waterproofing Project:

Spearheaded by UVCEGA Vice President Lt. Sukumar Rao (Retd.), this critical project was successfully executed between May 4 and June 10, 2025. Undertaken in close coordination with the college administration, the initiative aimed to improve living conditions for students. The Director of UVCE provided full support throughout the process, ensuring timely and effective completion. Budget allocation for this work is planned in the upcoming financial cycle, and the project stands as a testament to UVCEGA's dedication to enhancing campus infrastructure.

- College Website Management:

UVCEGA has consistently supported the maintenance and upkeep of the college's official website, including hosting and associated technical costs. Initially managed by VisionUVCE for over three years, the responsibility was transitioned to UVCEGA in the past five years. 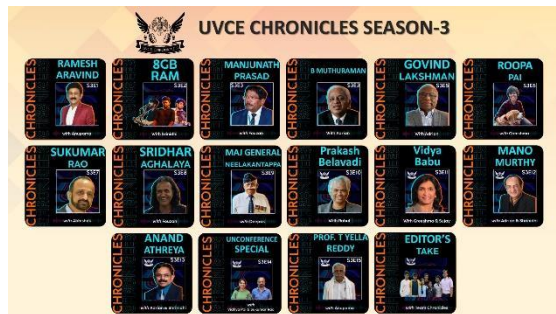

## SheSpeaks

A platform dedicated to empowering women in engineering, *SheSpeaks* hosted two impactful events in 2024–25 at UVCE. Alumni shared insights on communication, placements, and navigating careers. These sessions fostered openness, confidence, and community among women students and alumni.

### Hostel Samvaada

As part of its mission to bridge the gap between students and alumni, VisionUVCE, through UVCEGA, regularly organizes hostel visits to connect with students on campus. These visits aim to create a space for open interaction, understand students' needs and challenges firsthand, and identify areas where alumni can offer meaningful support - be it academic, professional, or personal.
